Would be good if it could serve both the Aquatic Centre and the general public. May need security eg MLAK. Copy of quote to be given to Michael Porter and Peter Shales. Continue discussion at the next meeting.**
- 2 Access around the Macksville foreshore and bridge, noting Council’s successful grant for lighting the bridge project.**
- 3 Stepped drain outside Pioneer Community Centre in Bowraville, difficult to see at night – possible solution of yellow reflective strip. Alba Sky to report via Council’s Customer Request system. Gradual installation of brighter LED street lighting around the Shire’s towns was noted.**
- 4 The Inclusive Tourism module Stream 2 was completed and the Committee was thanked for its interest and involvement.**
