WASTE & ENVIRONMENT LEVY	
From 1 July 2009 waste materials deposited at Nambucca landfill have attracted a State Government Waste & Environment Levy. The levy rate is adjusted in line with CPI annually. Disposal charges commence 1 July 2023 and are inclusive of GST. The EPA waste and environment levy for 2024/25 is \$97.90 and only applied to material deposited to landfill.

WEIGHBRIDGE	
The computerised weighbridge at the Nambucca Waste Facility provides accurate reporting, weighing and charging of all waste materials. The cost per tonne charge at the entry gate reflects the costs involved in landfilling . Annual servicing and maintenance of the weighbridge equipment for accuracy is undertaken by a Licenced Weighing Company.	

BULKY GOODS (Household Only)

TOWN AREAS - KERBSIDE

Residential properties **only** that are located on the kerbside bin collection route will be entitled to **one kerbside bulky goods collection service per year**. A maximum of 3 cubic metres (approximately 1 box trailer load) will be collected from each premise. General waste and scrap metal / white goods waste must be placed in separate piles, lengths must not exceed 2 metres.

Acceptable Items Only

- Bath tubs
- Soft furnishings
- Carpet & lino (generated from home)
- Non – recyclable household items
- Mattresses
- Small appliances
- Televisions
- Computers
- White goods (fridges, freezers etc)
- Scrap metal items

PLEASE NOTE materials should be placed at the kerb no sooner than the day before the date of the collection. **Materials placed out after the collection date, or are greater than 3 cubic metres in size will NOT be collected.** Please contact the Coffs Coast Waste Services Hotline 1800 265 495 for relevant dates and collection areas.

RURAL AREAS - VOUCHER

Rural properties that are **not** located on the kerbside bin collection route will be entitled to **one tipping voucher per year** that will allow residents to take up to 3m3 (1 box trailer load) of bulky household waste to the Nambucca Waste Management Facility for free disposal. To request your vouchers call the Coffs Coast Waste Service Hotline on 1800265495. They will ask for your name and address and will post the vouchers out to you. The vouchers will have a unique serial number which will be allocated to your address and will not be transferable. Present your voucher to the staff at the Nambucca Waste Management Facility and they will check your waste to ensure it fits within the guidelines and will ask you to confirm your name and address. Please note that 1 voucher per 3m3 trailer load is allowed and all waste materials must be separated at the site accordingly.

KERBSIDE BIN COLLECTION

Coffs Coast Waste Services (CCWS) has implemented a three bin kerbside collection service. It is very important that your waste is sorted correctly and placed into the right bins to avoid contamination of the different waste streams and help keep costs to a minimum. Please refer to the booklet delivered with your bins for information on which type of waste should go into which bin, the collection days and the collection frequency of the service.

LID COLOUR	COLLECTION	WASTE TYPE
YELLOW	Fortnightly	Recyclables
RED	Alternate Fortnightly	Other waste
GREEN	Weekly	Green waste & food scraps

The bins are to be placed at the kerbside the night before with the wheels facing the house. Please note that any rubbish put out in boxes or plastic bags and placed out separately will not be collected. Bins remain the property of the collection contractor and residents are not to remove the bins when vacating the premises. A wheel in wheel out collection service is available to elderly and disabled residents who meet and fulfil the requirements on application. **For further information or queries contact the Coffs Coast Waste Services Hotline 1800 265 495**

WASTE SEPARATION

Waste separation will avoid higher landfill charges, State Government landfill levies and reduce waste going to landfill. The benefits will be more money in your pocket and a cleaner and greener environment for generations to come.

HAZARDOUS CHEMICALS

It is important to dispose of unwanted hazardous chemical correctly. Never put them in your waste bin, pour them down the drain or onto the ground. Contact Nambucca Waste Facility to make arrangements for free disposal of unwanted household chemicals.

ILLEGAL DUMPING

The unauthorised dumping of waste materials on private or public land is illegal. In NSW serious penalties apply under the Protection of the Environment Operations Act. These include on the spot fines for individuals and corporations. State and Local Government Rangers are now monitoring and patrolling the local area.
