The Community Strategic Plan is the highest level plan that a council prepares. The purpose of the Plan is to identify the community's main priorities and aspirations for the future and to plan strategies to achieve that future.

The Community Strategic Plan addresses four key questions for the community:

- Where are we now?
- Where do we want to be in ten years time?
- How will we get there?
- How will we know we've arrived?

This Community Strategic Plan is based on the Social Justice Principles of equity, access, participation and rights.

**Equity** — there should be fairness in decision-making, prioritising and allocation of resources, particularly for those in need. Everyone should have a fair opportunity to participate in the future of the community. The planning process should take particular care to involve and protect the interests of people in vulnerable circumstances.

Access — all people should have access to services, resources and opportunities to improve their quality of life.

**Participation** — everyone should have the maximum opportunity to genuinely participate in decisions which affect their lives. **Rights** — equal rights should be established and promoted, with opportunities provided for people from diverse linguistic, cultural and religious backgrounds to participate in community life.

### Community Engagement Strategy

This Strategic Plan is a result of an ongoing conversation with our Community. The previous (and first) Plan was published in 2013 after an extensive consultation process; but the conversation didn't stop there. In 2014 a series of public meetings were held as part of consultation on a special rate variation for 2015 to 2017. In 2015 Council consulted widely on The Council improvement process for Fit for the Future Council Local Government Reforms. Council also received feedback on various Master Plans including the Open Space Strategy, Dawkins Park Landscape Enhancement Plan, Macksville Town Centre Revitalisation Plan, Nambucca Flood Risk Management Plan, review of developer contribution plans and the Nambucca Koala Habitat Study.

Every three years Council commissions a Community Satisfaction Survey. The first was in 2007 and the most recent was in 2016 - these surveys provide an invaluable insight into residents' changing priorities. They are also a score card as to how our community rates the range and quality of services provided by the Nambucca Shire Council.

Council meets twice a month and at each meeting there is a public forum where residents are invited to address Council on a topic that concerns them. Delegations from the public on items on the Agenda are invited. Councillors ask questions and hot topics of the moment, ongoing concerns, plans and ideas for the future are regularly discussed. Another opportunity for Public participation in the process of Local Government is during the public exhibition stage of the Shire's regulatory planning and reporting documents. Nambucca Shire is also represented at Community Forums in partnership with State and Federal agencies responsible for delivering services ranging from Health, Youth, Indigenous Social Justice and Regional Development.

As part of the 2017 review of the Community Strategic Plan, open community forums were held where people were invited to share their vision for the Nambucca Valley in 2027.

Targeted feedback was also sought on one of the key issues for this term of Council and beyond; the impact of the Pacific Highway upgrade. This will include the bypassing of Macksville and there was a focus on planning for Macksville "post bypass". Another popular theme was the impact on the Community of quicker, easier access to the large regional centre of Coffs Harbour. Topics of conversation included whether there will be an influx of people who commute to Coffs Harbour for work and concern that local spending will leak to the neighbouring local economies.

These conversations and others like them will need to continue so all people of the Nambucca Valley can inform decisions that shape their future. The Nambucca Shire Council is committed to making sure this happens.

### Making it happen

Council has a key role in shaping the future of the Nambucca Valley, however, there are many other players in the team. These include community organisations, local businesses, the State and Federal Government and most importantly, our residents. A team approach means there is coordination and cooperation to achieve the community's needs at the minimum cost.

Council's contribution to achieving the outcomes in this Plan will be expressed in a Resourcing Strategy and a series of four year Delivery Programs and Annual Operational Plans.

Council will report back to the community at regular intervals on what has been achieved.

# **Objective -** Our Community will be a safe healthy place to live where everyone is valued.

### Strategy 1.1 Civic leadership and administration

- **Citizen Engagement** Council engages the Community in the process of open government and public participation is encouraged not only in policy development and major decisions, but in the day to day operations of the Council.
- Sustainable Delivery of Services - Council delivers services that reflect the priorities of the community and makes best use of the available resources.

- Risk Management Council will identify and manage risks likely to have a material impact on the organisation's ability to achieve its mission and objectives.
- Sustainable Energy Use -Nambucca Shire Council will provide Community leadership in sustainable energy use.

#### Strategy 1.2 Public order and safety

- **Community Safety** The Nambucca Shire shall foster Communities where people feel safe and secure.
- Companion Animal Welfare - Companion Animals will be proactively managed to ensure the community's safety and high standard of animal welfare.

#### Strategy 1.3 Public health

- **Safe Food** The Nambucca Shire Council will guard against illness caused by unhealthy food by promoting and enforcing food hygiene standards.
- Clean Water Council will ensure Nambucca waterways will not be contaminated by on-site sewerage systems. This will be achieved by an efficient monitoring regime and effective enforcement of the current standards.
- Personal Health and Wellbeing -Council will seek to improve the overall health and wellbeing of the community of the Nambucca Valley by supporting public health initiatives, and advocating for improved aged care and health services.

### Strategy 2.1 Well planned Communities

- Well Planned Communities -The Nambucca Valley aspires to be a community that minimises its environmental footprint and social costs while maximising the economic and social wellbeing of its residents.
- Housing Housing across the Nambucca Shire provides choice and is affordable.

#### Strategy 2.2 Building regulation

**Safe Buildings and Pools -** Building and swimming certification will be achieved in an accurate and timely manner. An effective risked based compliance program for fire and pool safety will be maintained.

### Strategy 2.3 Environmental services and Community amenities

- Waste Management The natural environment will be protected through ensuring cost effective and environmentally responsible management of solid waste.
- **Street Cleaning** Regular street cleaning will minimise the creation of litter and reduce contaminates in storm water run-off.

- Environmental Protection

   Council will seek to protect our natural environment by strategically managing operations and development and regulating activities with environmental impacts.
- **Biodiversity** The biodiversity of the Nambucca Valley will be protected and enhanced.
- **Cemeteries** Well maintained cemeteries shall be provided across the Shire.
